The well will be completed as a well in the Fulcher Kutz Pictured Cliffs Pool. The well is non-standard because it is only 493 feet from the northern boundary of the spacing unit. The well is staked within the Farmington City limits in a residential area.

Finding an acceptable drilling location within the city limits is a near impossibility. Merrion has worked with the landowner to place the location so as to minimize the impact on his development plans. As Exhibit 3 shows, the well is just north of future home sites. Moving the well south would mean the landowner would lose the ability to develop those lots.

The well is encroaching on the SW/4 of Section 25, T30N, R13W to the north of the location. Merrion is the owner and operator of the only affected offset Pictured Cliffs spacing unit. Therefore, no additional notification of offset owners was done.







EXHIBIT 4 OFFSET OPERATOR PLAT BLACKSHAWL COM 1 NON-STANDARD LOCATION APPLICATION


