Dear Mr. Fesmire:

Pursuant to NMAC 19.15.15.13, Cimarex Energy Co. of Colorado applies for approval of an unorthodox oil well location for the following well:

<u>Well:</u>	State A 14 Well No. 1
<u>Surface:</u>	1710 feet FNL & 2095 feet FWL
<u>Well unit:</u>	SW¼NE¼ §14-19S-29E, Eddy County, New Mexico

The well was drilled to and completed in the Morrow formation in 1980, and is now nearing its economic limit. The unorthodox location was approved by Order Nos. R-6190 and R6190-A (the well is in the oil-potash area, under which locations are limited).

Applicant intends to re-complete the well uphole in the Wolfcamp formation (North Parkway-Wolfcamp Pool). The alternative is to P&A the well. The subject pool is spaced on statewide rules, with 40 acre spacing and wells to be located no closer than 330 feet to a quarter-quarter section line. A Form C-102 is attached as Exhibit A.

All of Section 14 is covered by a JOA under which Magnum Hunter Production, Inc. (a sister corporation to applicant) and Hunt Oil Company own the working interest 50-50. In addition, all of Section 14 is state minerals, so royalty ownership is common. (The NE¼ of Section 14 is a single state lease, with common ownership (Exhibit B), so no override is affected by the application.) Therefore, no one has been notified of the application.
