Dear Mr. Jones:

Mack Energy Corporation respectfully requests an amendment to SWD-1175, for the Runway SWD #1 Sec. 20 T14S R29E as a Devonian disposal. This well was permitted to drill to a TD of 10,750' and run 5 ½ casing and cement to surface. We have lost circulation at +- 10,500' and have been unable to regain circulation and currently TD @ 10,650'. We now are proposing to set 5 ½ casing @ 10,170' (base of Mississippian Lime) w/packer and DV Tool. There will also be a DV Tool @ 7300'. Cement will be two stages, 1st from 10,170'-7300', 2nd from 7300'-surface. This SWD will now be open hole disposal from **Mississippian Lime through Devonian at a depth of 10,170'-10,650'**.






