The footages for the CDU injection wells to be drilled have changed slightly from what we initially stated on the C108.

CDU 439 - 1876' FSL 980' FWL – Sec 29 T-21S R-37E UL-K ----- Reported on C108  
1910' FSL 810' FWL ----- Has changed to

CDU 440 - 959' FSL 2519' FWL – Sec 29 T-21S R-37E UL-N ----- Reported on C108  
2518.8 ----- Has changed to

CDU 441 - 933' FNL 602' FWL – Sec 32 T-21S R-37E UL-D ----- Reported on C108  
932.5' 557.7 ----- Has changed to
