Gentlemen:

Aztec Oil & Gas Company hereby submits its application for administrative approval of a non-standard gas proration unit comprising the South half ($S\frac{1}{2}$), (or lots 8-15, inclusive), of Section 30, Township 29 North, Range 9 West, N.M.P.M., San Juan County, New Mexico, and in support thereof respectfully states and shows the following:

1. That the Aztec-Cain No. 3 well, located 990 feet from the South line and 2310 feet from the West line of Section 30, Township 29 North, Range 9 West, was completed December 8, 1948 as a gas well and connected to Southern Union Gas Company's pipeline in January, 1953.
2. That the proposed non-standard gas proration unit consists of 268.42 acres which are contiguous lots.
3. That the proposed non-standard gas proration unit lies wholly within a single governmental section.
4. That the proposed non-standard gas proration unit may reasonably be presumed to be productive of gas.
5. So far as is known to Applicant, the following companies constitute the only companies, other than Applicant, owning an interest in any of the acreage included in or offsetting the proposed unit, and such companies are being notified by registered mail of this proposed non-standard gas proration unit by the mailing of a copy of this application to them:

Therefore, Aztec Oil & Gas Company respectfully requests that under the provisions of Rule 1(b) of Order No. R-128-C, the Secretary of the Commission grant an exception to Rule 1(a), without notice and hearing, approving the non-standard gas proration unit hereinabove requested.
