Aztec Oil & Gas Company hereby submits its application for administrative approval of a non-standard gas proration unit comprising the NW1 (or ENW1; Lot 1; Lot 2) of Section 30, Township 28 North, Range 10 West, N.M.P.M., San Juan County, New Mexico, and in support thereof respectfully states and shows the following:

- That the Aztec-Newman No. 5-B Well, located 330 feet from the North line and 1650 feet from the West-Line of Section 30, Township 28 North, Range 10 West, was completed October 12, 1948 as a gas well and connected to Southern Union Gas Company's pipeline on November 10, 1948.
- 2. That the proposed non-standard gas proration unit consists of 164.65acres which are contiguous quarter-quarter sections and lots.
