The New Mexico Oil Conservation Division (OCD) has completed a review of the following Texas-New Mexico Pipe Line Company (TNMPLC) documents which were submitted on behalf of TNMPLC by their consultant KEI:

- December 21, 1998 "GROUND WATER MONITORING EVENT, TEXAS - NEW MEXICO PIPE LINE COMPANY, MONUMENT SITE 5, MONUMENT, NEW MEXICO, JOB NO. 610057-6-5" which was recieved by the OCD on January 22, 1999.
- September 16, 1998 "GROUND WATER MONITORING EVENT, TEXAS - NEW MEXICO PIPE LINE COMPANY, MONUMENT SITE 5, MONUMENT, NEW MEXICO, JOB NO. 610057-6-5".
- September 10, 1998 "CLOSURE REPORT, MONUMENT SITE 5, UNIT G, SECTION 25, TOWNSHIP 19 SOUTH, RANGE 36 EAST, LEA COUNTY, NEW MEXICO, JOB NO. 610057-2-5".

These documents contain the results of TNMPLC's investigation, remediation and monitoring of soils and ground water resulting from a crude oil pipeline spill at TNMPLC's Monument No. 5 site. The documents also request closure of remediation and monitoring activities.

The above referenced closure request is approved.

Texas - New Mexico Pipe Line Company (TNMPL) submitted a State of New Mexico Commissioner of Public Lands Application for Water Exploration/Development for 3 wells at Site No. 5 dated May 21, 1998. TNMPL also submitted a check in the amount of \$930.00 for one year's rental.

The New Mexico Oil Conservation Division (OCD) has given TNMPL verbal approval to close the site because further investigation demonstrated TNMPL did not cause the ground water impact. However, OCD requested that TNMPL not plug the wells at the site. OCD would like to utilize these wells for future surrounding area investigations. Therefore, as requested by OCD, TNMPL requests transfer of well ownership to OCD and all rights and responsibilities to OCD.
