Gentlemen:

El Paso Natural Gas Company hereby submits its application for administrative approval of a non-standard unit comprising the South Half (S/2) (or SE/4 SE/4, SW/4 SE/4, SE/4 SW/4, SW/4 SW/4, Lots 1, 2, 3 and 4) of Section 10, Township 28 North, Range 8 West, San Juan County, New Mexico, and in support thereof states the following facts:

- 1. The Jones #1-A Well, located 800 feet from the South line, and 1550 feet from the West line of Section 10, Township 28 North, Range 8 West, San Juan County, New Mexico, was completed as a gas well on March 30, 1955.
- 2. That the proposed non-standard gas proration unit consists of 293.84 acres which are contiguous quarter-quarter sections and lots.
- 3. That the proposed non-standard gas proration unit lies wholly within a single government section.
- 4. That the proposed non-standard gas proration unit may reasonably be presumed to be productive of gas.
- 5. That by copy of this letter of application all operators owning interests (a) in the section in which any part of the non-standard proration unit is situated and which acreage is not included in said non-standard gas proration unit, and (b) in acreage offsetting the non-standard gas proration unit, are notified by registered mail of this proposed non-standard gas proration unit.


