Gentlemen:

El Paso Natural Gas Company, as Unit Operator of the San Juan 29-7 Unit, hereby submits its application for administrative approval of a non-standard proration unit comprising the West Half (W/2) (or Lot 10, 11, 12, 13, 14, SE/4 NW/4, NE/4 SW/4 SE/4 SW/4) of Section 6, Township 29 North, Range 7 West, Rio Arriba County, New Mexico, and in support thereof submits the following facts:

1. The San Juan 29-7 Unit Hickman #1 Well, located 990' from the South line and 1000' from the West line of Section 6, Township 29 North, Range 7 West, was completed as a gas well on October 18, 1952, and connected to El Paso Natural Gas Company's gathering system on March 11, 1953.
2. That the proposed non-standard gas proration unit consists of 215.22 acres which are contiguous quarter-quarter sections and lots.
3. That the proposed non-standard gas proration unit lies wholly within a single governmental section.
4. That the proposed non-standard gas proration unit may reasonable be presumed to be productive of gas.
5. That by copy of this letter of application all operators owning interests (a) in the section in which any part of the non-standard proration unit is situated and which acreage is not included in said non-standard gas proration unit, and (b) in acreage offsetting the non-standard gas proration unit, are notified by registered mail of this proposed non-standard gas proration unit.


