Re: Application for Exception to Rule 1(a)
of Order No. R-128-C for Non-Standard
Proration Unit, Blanco-Mesaverde Gas
Pool, San Juan County, New Mexico.

Gentlemen:

El Paso Natural Gas Company hereby submits its application for administrative approval of a non-standard proration unit comprising the North Half (N/2) (or Lots 1, 2, NE/4 NW/4, SE/4 NW/4, NW/4 NE/4, NE/4 NE/4, SE/4 NE/4, SW/4 NE/4) of Section 19, Township 28 North, Range 8 West, San Juan County, New Mexico, and in support thereof states the following facts:

1. The Florance #1-C Well, located 990 feet from the North line and 990 feet from the East line of Section 19, Township 28 North, Range 8 West, was completed as a gas well on December 15, 1952, and connected to El Paso Natural Gas Company's gathering system on March 23, 1953.
2. That the proposed non-standard gas proration unit consists of 313.00 acres which are contiguous quarter-quarter sections and lots.
3. That the proposed non-standard gas proration unit lies wholly within a single governmental section.
4. That the proposed non-standard gas proration unit may reasonably be presumed to be productive of gas.
5. That by copy of this letter of application all operators owning interests (a) in the section in which any part of the non-standard proration unit is situated and which acreage is not included in said non-standard gas proration unit, and (b) in acreage offsetting the non-standard gas proration unit, are notified by registered mail of this proposed non-standard gas proration unit.

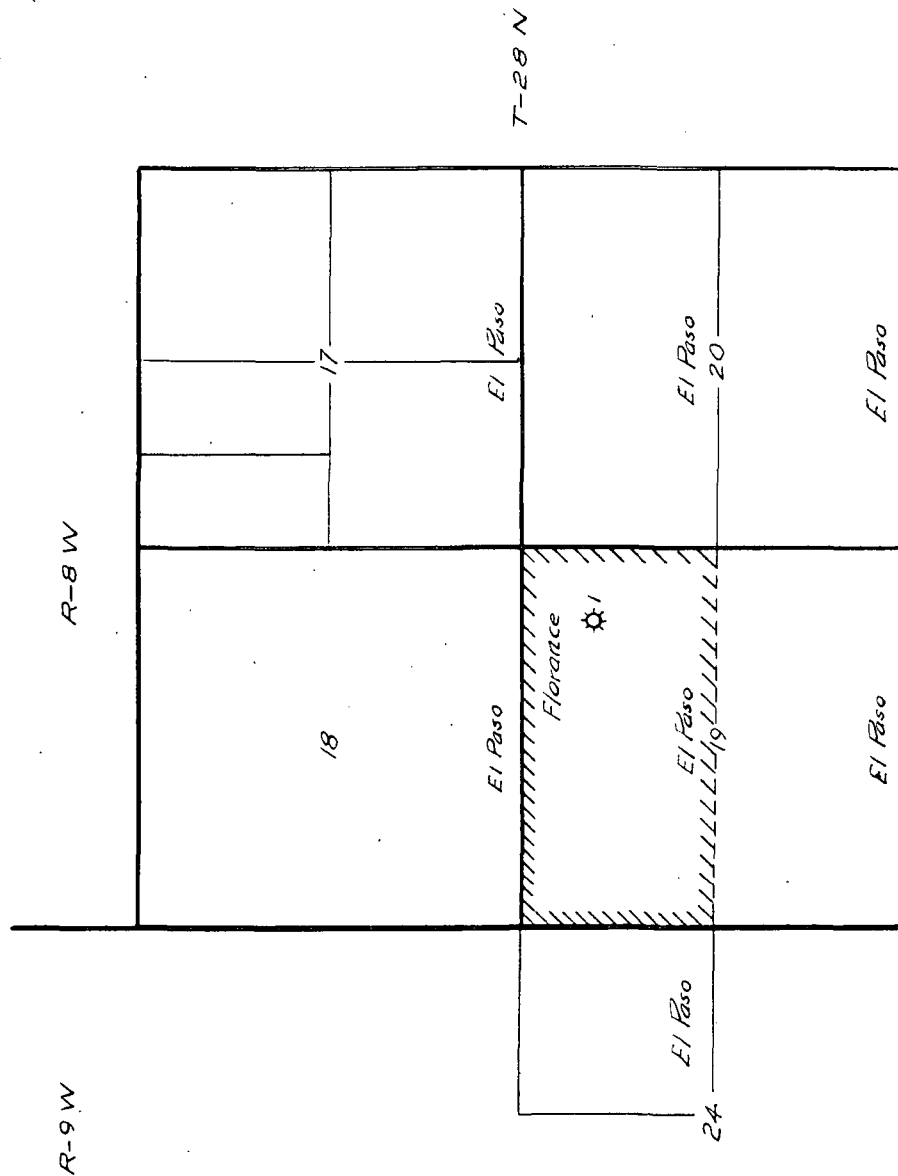
