Gentlemen:

El Paso Natural Gas Company, as Unit Operator of the San Juan 28-7 Unit, hereby submits its application for administrative approval of a non-standard proration unit comprising the East Half (E/2) (or Lots 3, 4, NW/4 SE/4, NE/4 SE/4, SW/4 NE/4, SE/4 NE/4, NW/4 NE/4, NE/4 NE/4) of Section 35, Township 28 North, Range 7 West, Rio Arriba County, New Mexico, and in support thereof states the following facts:

1. The San Juan 28-7 Unit #7 Well, located 990' from the North line and 990' from the East line of Section 35, Township 28 North, Range 7 West, was completed as a gas well on June 15, 1953, and connected to El Paso Natural Gas Company's gathering system on July 10, 1953.
2. That the proposed non-standard gas proration unit consists of 327.70 acres which are contiguous quarter-quarter sections and lots.
3. That the proposed non-standard gas proration unit lies wholly within a single governmental section.
4. That the proposed non-standard gas proration unit may reasonably be presumed to be productive of gas.
5. That by copy of this letter of application all operators own-interests (a) in the section in which any part of the non-standard proration unit is situated and which acreage is not included in said non-standard gas proration unit, and (b) in acreage offsetting the non-standard gas proration unit, are notified by registered mail of this proposed non-standard gas proration unit.


