Standard Proration Unit, Blanco
Mesaverde Gas Pool, Rio Arriba
County, New Mexico.

Gentlemen:

El Paso Natural Gas Company, as Unit Operator, of the San Juan 28-6 Unit, hereby submits its application for administrative approval of a non-standard proration unit comprising the South Half (S/2) (or SE/4 SE/4, SW/4 SE/4, SE/4 SW/4, SW/4 SW/4, and Lots 1, 2, 3 and 4) of Section 8, Township 28 North, Range 6 West, Rio Arriba County, New Mexico, and in support thereof states the following facts:

1. The San Juan 28-6 #13 well located 990 feet from the South line and 1550 feet from the West line of Section 8, Township 28 North, Range 6 West, was completed as a gas well October 19, 1954, and connected to El Paso Natural Gas Company's gathering system December 7, 1954.
2. That the proposed non-standard gas proration unit consists of 285.00 acres which are contiguous quarter-quarter sections and lots.
3. That the proposed non-standard gas proration unit lies wholly within a single governmental section.
4. That the proposed non-standard gas proration unit may reasonably be presumed to be productive of gas.
5. That by copy of this letter of application all operators owning interests (a) in the section in which any part of the non-standard proration unit is situated and which acreage is not included in said non-standard gas proration unit, and (b) in acreage offsetting the non-standard proration unit, are notified by registered mail of this proposed non-standard gas proration unit.


