6(a) Revised of Order No. R-565,
for Non-Standard Proration Unit,
Aztec-Pictured Cliffs Pool,
San Juan County, New Mexico.

Gentlemen:

El Paso Natural Gas Company hereby submits its application for administrative approval of a non-standard proration unit comprising the Southwest Quarter (SW/4) (or NE/4 SW/4, SE/4 SW/4, Lots 3 and 4) of Section 18, Township 30 North, Range 10 West, San Juan County, New Mexico, and in support thereof states the following facts:

1. The Schumacker #3 Well, located 990 feet from the South line and 1650 feet from the West line of Section 18, Township 30 North, Range 10 West, was completed as a gas well on November 1, 1952, and connected to El Paso Natural Gas Company's gathering system May 26, 1953.
2. That the proposed non-standard gas proration unit consists of 156.50 acres which are contiguous quarter-quarter sections and lots.
3. That the proposed non-standard gas proration unit lies wholly within a single governmental section.
4. That the proposed non-standard gas proration unit may reasonably be presumed to be productive of gas.
5. That by copy of this letter of application all operators owning interests (a) in the section in which any part of the non-standard proration unit is situated and which acreage is not included in said non-standard gas proration unit, and (b) in acreage offsetting the non-standard proration unit, are notified by registered mail of this proposed non-standard gas proration unit.


