Gentlemen:

We acknowledge receipt of a carbon copy of your letter dated March 23, 1956, to the New Mexico Oil Conservation Commission requesting approval for the non-standard proration unit described in the above caption.

We wish to advise that El Paso Natural Gas Company as offset operator has no objection to the approval of this request. However, we fail to understand how the acreage figure of 144.77 was derived. Our latest re-survey dated May 10, 1949, shows no change in the previous survey as to the amount of acreage, and according to our plats, the total number of acres in the NE/4 of Section 2, Township 27 North, Range 9 West is 159.15.

Rule 6 (A) of Order #565 issued by the New Mexico Oil Conservation Commission states in part as follows:

"For the purpose of gas allocation in the Fulcher Kutz-Pictured Cliffs gas pool, a standard proration unit shall consist of approximately 160 surface contiguous acres substantially in the form of a square which shall be a legal subdivision (quarter-section) of the U. S. Public Land Survey;

The allowable production from any non-standard gas proration unit as compared with the allowable production therefrom if such tract were a standard


unit shall be in the ratio which the area of the non-standard proration unit bears to a standard proration unit of 160 acres. Any gas proration unit containing between 158 and 162 acres shall be considered to contain 160 acres for the purpose of computing allowables."

Therefore, if the acreage figure of 159.15 is correct, it would appear that the NE/4 of Section 2, Township 27 North, Range 9 West would be considered a standard proration unit, and no application for non-standard proration unit would be required.

Dear Mr. Porter:

We are changing the acreage dedication for the Skelly Oil Company's #1 Hobbs "C" well in 2-27N-9W from the May, 1949, Dependent Resurvey Plat to the 1882 Plat.

All other wells in this township have been prorated on the basis of the 1882 Plat. Most of the leases of this township were purchased according to the 1882 survey.

Administrative Order NWU-173 was based on the 1949 survey and we recommend that Skelly Oil Company request cancellation of that order.

The dedicated acreage according to the 1882 Plat would be 159.15 acres which is a standard proration unit.



Dear Sir:

Administrative Order NWU-173 which was erroneously based on the 1949 survey, was issued on April 5, 1956, on our Hobbs "C" well No. 1, which is located in the NE/4 of Section 2 - 27 North - 9 West, San Juan County, New Mexico.

All other wells in this township have been prorated on the basis of the 1882 plat, which indicates that our well should be credited 159.15 acres. On April 10, 1956, we were advised by our Farmington office that this quarter section consisted of 159.15 acres and that all records had been changed by the New Mexico Oil and Gas Conservation Commission. Therefore, it is in order to cancel administrative order NWU-173 and assign our well credit for 159.15 acres from inception.

Gentlemen:

We are proposing to drill our Hobbs "C" Well No. 1 to the Pictured Cliffs formation of the South Blanco Field in Section 2, Township 27 North, Range 9 West which will be the only well on the NE/4 of Section 2 but will have only 144.77 acres rather than the normal 160 acres. This is due to adjustment along the North line of this particular township.

Since it will be non-standard, request is made for approval of this State lease on the subnormal section.

El Paso Natural Gas Company is the only other lease holder offsetting our Hobbs "C" lease and by carbon copy of this lease we are giving them formal notice of our request and trust that they will forward to you direct waiver of their objections.
