- 4. That the proposed non-standard gas proration unit may reasonably be presumed to be productive of gas.
- 5. That El Paso Natural Gas Company is the owner of all the interest in Section 31, Township 28 North, Range 8 West, and El Paso Natural Gas Company is the owner of all the interest in acreage offsetting the proposed non-standard proration unit.
