1. The Johnston #7 Well, located 1180' from the South line and 1840' from the West line of Section 11, T-28-N, R-9-W, was completed as a gas well from the Mesaverde Formation on April 16, 1957.
2. That the proposed non-standard gas proration unit consists of 267.72 acres, which are contiguous quarter-quarter sections and lots.
3. That the proposed non-standard gas proration unit lies wholly within a single government section.
4. That the proposed non-standard gas proration unit may reasonably be presumed to be productive of gas.
5. That by copy of this letter of application all operators owning interests (a) in the section in which any part of the non-standard proration unit is situated and which acreage is not included in said non-standard gas proration unit, and (b) in acreage offsetting the non-standard gas proration unit, are notified by registered mail of this proposed non-standard gas proration unit.
