MPCo. #4 (MV) Jicarilla "E", Section 11-27N-3W,
Application for Non-Standard Proration Unit.

Application is hereby made for administrative approval of a 367.60 acre non-standard gas proration unit in the Blanco Mesa Verde Pool in Rio Arriba County, New Mexico. The producing well of this unit is designated as the Magnolia Petroleum Company #4 (MV) Jicarilla "E" and is located 990 FWL and 990 FSL of Section 11-27N-3W; the nominated area of the gas proration unit is all of fractional Section 11 consisting of 367.60 acres.

The following statements are made in support of this application.

1. The nominated area for the 367.60 acre non-standard unit consists of continuous and contiguous acreage.
2. The nominated area lies wholly within a governmental section.
3. The nominated area is judged to be reasonably productive of gas in its entirety.
4. Gas and Oil operating rights are held by the Magnolia Petroleum Company and no other ownership is within the limits of the proposed gas proration unit.

5. All operators known to have a leasehold interest in offsetting acreage in Section 11-27N-3W are notified by registered mail of this application.
6. A plat showing acreage to be committed to the proposed non-standard gas proration unit, the location of the designated well and known offset ownership is attached hereto and made a part of this application.
7. This unit will apply only to the Mesa Verde completion in the MPCo. #4 Jicarilla "E" well.

In view of the existence of the foregoing facts as stated and in full compliance with the provisions of Rule 1(b) of OCC Order R-520, the Magnolia Petroleum Company respectfully requests administrative approval of the proposed 367.60 acre non-standard gas proration unit.


