
1. Applicant is operator of the Federal Elliott "C" lease consisting of the E $\frac{1}{2}$ SW $\frac{1}{4}$ of said Section 34.
2. Applicant is the operator of the Federal Elliott "C" Well No. 1 which was completed December 3, 1957. Said well is in the defined limits of the Bisti-Lower Gallup Oil Pool.
3. Said proposed proration Unit consists of contiguous quarter-quarter sections.
4. Said proposed proration Unit lies wholly within a single governmental quarter section.
5. The ownership of off-set acreage is such that there will be no hardship effected on off-set operators.
6. Copies of this application have been furnished this date by registered mail to all off-set operators and all operators within a 2640-foot radius of the subject well.

A plat is attached hereto showing to the best of our knowledge and belief the proposed Unit, the location of Well No. 1, offset wells and ownership thereof.

The granting of this application is in the interest of preventing waste and the protecting of correlative rights.

In view of the facts set out herein it is respectfully requested that the Commission enter an Order approving the proposed 80 acre proration Unit as described above.






