- The Ted M. White #1 Well, located 1800' from the South line and 1800' from the West line of Section 35, Township 29 North, Range 9 West, was completed as a gas well from the Pictured Cliffs Formation on June 25, 1958.
- 2. That the proposed non-standard gas proration unit consists of 153.07 acres; which are contiguous quarter-quarter sections and lots.
- 3. That the proposed non-standard gas proration unit lies wholly within a single government section.
- 4. That the proposed non-standard gas proration unit may reasonably be presumed to be productive of gas.
- 5. That by copy of this letter of application, all operators owning interests (a) in the section in which any part of the non-standard proration unit is situated and which acreage is not included in said non-standard gas proration unit, and (b) in acreage offsetting the non-standard gas proration unit, are notified by registered mail of this proposed non-standard gas proration unit.


