- The Rincon Unit #39 Well, located 1647' from the North 1. line and 1516' from the West line of Section 26, Township 27 North, Range 7 West, was completed as a gas well from the Pictured Cliffs Formation on May 5, 1955.
- 2. That the proposed non-standard gas proration unit consists of 168.74 acres, which are contiguous quarterquarter sections and lots.


