Gentlemen:

El Paso Natural Gas Company hereby submits its application for administrative approval of a non-standard proration unit consisting of the southeast quarter (SE/4) or (Lots 13,14, S/2 SE/4) of Section 31, Township 27 North, Range 6 West, Rio Arriba County, New Mexico, and in support thereof states the following facts:


1. The Rincon Unit #4 Well, located 1529' from the South line and 1019' from the East line of Section 31, Township 27 North, Range 6 West, was completed as a gas well from the Pictured Cliffs Formation on June 16, 1953.
2. That the proposed non-standard gas proration unit consists of 163.97 acres, which are contiguous quarter-quarter sections and lots.
3. That the proposed non-standard gas proration unit lies wholly within a single government section.
4. That the proposed non-standard gas proration unit may reasonably be presumed to be productive of gas.
5. That by copy of this letter of application all operators owning interests (a) in the section in which any part of the non-standard proration unit is situated and which acreage is not included in said non-standard gas proration unit, and (b) in acreage offsetting the non-standard gas proration unit, are notified by registered mail of this proposed non-standard gas proration unit.

Therefore, El Paso Natural Gas Company requests that under the provision of Rule 6(b) Revised of Order No. R-565-C, the Secretary of the Commission grant

exception to Rule 6(a) without Notice and Hearing and approve the subject non-standard gas proration unit.


