Re: Farming "E" Lease Section 2-24N-6W Rio Arriba County, New Mexico

Gentlemen:

Our Farming "E" Lease in Section 2 contains 683.38 acres, its abnormality along the north line being due to a correction of the township by the addition of four lots as follows:

> Lot 1 containing 11.04 acres and Lot 2 containing 10.91 acres, adjoining the northeast quarter of Section 2. Lot 3 containing 10.77 acres and Lot 4 containing 10.66 acres, adjoining the northwest quarter of Section 2.

Our No. 1 well, which is located 769' from the north line and 769' from the east line of abnormal Section 2, is completed as a Dakota gas well, and hence comes under the terms of Order No. R-1287. We desire to assign the east half of Section 2 which contains the normal 320 acres plus 11.04 acres of Lot 1 and 10.91 acres of Lot 2 for a total of 341.95 acres. Under Rule I of said order, we would desire administrative approval from the Director of the Commission for its assignment.

Our No. 2 well, which is located 764' from the north line and 1870' from the east line of abnormal Section 2, comes under the provisions of Rule 104 of the Statewide Rules; and administrative approval is sought to assign to this 40 acres the 10.91 acres of Lot 2 adjoining it on the north for a total assignment of 50.91 acres.

Since both wells are in undesignated fields, the No. 1 being an undesignated Dakota gas well and No. 2 being an undesignated Gallup oil well, administrative approval is sought under their respective orders. In addition, the No. 1 well is 769' from the nearest outside lines; whereas, Oil Conservation Commission Page -2

the prescribed rules require 790¹. Administrative approval is further sought due to the unorthodox size or shape of the tract resulting from variation in the legal subdivision of the United States Public Land Survey.
