Gentlemen:

Please consider this as an application for administrative approval, in accordance with Rule 104 (m) of the Commission Rules and Regulations, for non-standard oil proration units for wells No. 3, 11 and 16 on our Jicarilla "B" lease Otero-Gallup Pool, Rio Arriba County, New Mexico, which has recently been brought to our attention.

The requested units are as follows:

Well No. 3, located 660' FN and WL Section 5-24N-5W.
Lot 4 (12.29 acres) and NW/4 NW/4 Section 5-52.29 acres.

Well No. 11, located 660' FNL and 1980' FEL Section 5-24N-5W. Lot 2 (12.49 acres) and NW/4 NE/4 Section 5-52.49 acres.

Well No. 16, located 543' FNL and 1912' FEL Section 6-24N-5W. Lot 2 (12 acres) and NW/4 NE/4 Section 6-52 acres.


Sections 5 and 6 are abnormal sections due to township correction resulting in additional acreage designated as lots. We are attaching a plat of the area and 3 copies of certified plat for each of the above wells showing the 40 acre units and the lots adjoining them.
