Gentlemen:

Pubco Petroleum Corporation hereby submits its application for administrative approval of a non-standard unit comprising the North Half (N $\frac{1}{2}$ ) (or Lots 1,2,3,4,5, SE $\frac{1}{4}$ NW $\frac{1}{4}$ , S $\frac{1}{4}$ NE $\frac{1}{4}$ ) of Section 6, Township 29 North, Range 11 West, San Juan County, New Mexico, and in support thereof states the following facts:


1. The Federal #6-B Well, located 990 feet from the North line and 1650 feet from the East line of Section 6, Township 29 North, Range 11 West, is to be drilled and completed as a Dakota gas well.
2. That the proposed non-standard gas unit consists of 288.18 acres which are contiguous quarter-quarter sections and lots.
3. That the proposed non-standard gas unit lies wholly within a single government section.
4. That the proposed non-standard gas unit may reasonably be presumed to be productive of gas.
5. That the length and width of the proposed non-standard gas unit does not exceed 5280 feet.
6. That by copy of this letter of application all operators owning interests (a) in the section in which any part of the non-standard unit is situated and which acreage is not included in said non-standard gas unit, and (b) in acreage offsetting the non-standard gas unit, are notified by registered mail of this proposed non-standard gas unit.






