

We wish to acknowledge receipt of the above referenced Administrative Order and appreciate the expeditious manner in which you handled this for us. However, we wish to call your attention to a typographical error in the description of the unit. The description should show the unit located in Township 29 instead of 20.

Also, I believe the Fulcher-Kutz Pictured Cliffs pool rules provide for 160 acre proration units. Our unit is 160 acres. Should not the order refer to the unit as a 160 acre unit rather than a 320 acre unit as stated in the order.

We would appreciate an amendment to the above order with a copy of same to be mailed to the U. S. Geological Survey in Farmington inasmuch as we are contemplating filing a communitization agreement with them upon receipt of the amended order.



Township 29 North, Range 11 West, N.M.P.M.
San Juan County, New Mexico

Section 20: $N\frac{1}{2}S\frac{1}{2}$

containing 160 acres more or less

3. The $N\frac{1}{2}$ of the $S\frac{1}{2}$ of Section 20, Township 29 North, Range 11 West, N.M.P.M., San Juan County, New Mexico, consists of contiguous quarter-quarter sections lying wholly within a single governmental section and the entire 160 acres may reasonably be presumed to be productive of natural gas.

4. The Fulcher-Kutz Pictured Cliffs Pool Rules provide for a standard unit in the field to consist of 160 contiguous acres substantially in the form of a square which shall be a legal subdivision (quarter section) of the United States Public Land Survey, and further provide that the Secretary of the Commission shall have authority to grant an exception to such rules.

5. To the best of Applicant's knowledge and belief, the names and addresses of all operators other than Applicants herein owning acreage within Section 20, Township 29 North, Range 11 West, N.M.P.M., San Juan County, New Mexico, and all operators owning interest in acreage directly offsetting the $N\frac{1}{2}S\frac{1}{2}$, Section 20, Township 29 North, Range 11 West, N.M.P.M., San Juan County, New Mexico, are as follows:

WHEREFORE, premises considered, Applicants pray that the Secretary of

the New Mexico Oil Conservation Commission, in accordance with the authority contained in the Fulcher-Kutz Pictured Cliffs Pool Rules, grant the Applicants an exception from the requirements of the Fulcher-Kutz Pictured Cliffs Pool Rules so as to permit the Applicants to create and establish a non-standard proration unit composed of the N $\frac{1}{2}$ S $\frac{1}{2}$, Section 20, Township 29 North, Range 11 West, N.M.P.M., San Juan County, New Mexico, for the Summit Oil Company's Viles #3-B Well; or if the Secretary declines to grant an exception to such rules, then Applicants pray that this matter be set down for a hearing before an examiner designated by the Commission, and that upon any such hearing, Applicants be granted an exception from the requirements of the Fulcher-Kutz Pictured Cliffs Pool Rules so as to permit the Applicants to create a nonstandard proration unit, composed of the N $\frac{1}{2}$ S $\frac{1}{2}$, Section 20, Township 29 North, Range 11 West, N.M.P.M., San Juan County, New Mexico, for the Summit Oil Company's Viles #3-B Well.






