In accordance with Rule 5(B) of the Northwest portion of Order R-1670, El Paso Natural Gas Company, as Unit Operator of the Rosa Unit, hereby submits its application for administrative approval of a non-standard proration unit comprising All (or Lots 1,2,3,4, S/2) of Section 5, Township 31 North, Range 5 West, Rio Arriba County, New Mexico, and in support thereof states the following facts:

1. The Rosa Unit #41 Well, located 1500' from the South line and 1528' from the West line of Section 5, Township 31 North, Range 5 West, was completed as a gas well from the Mesaverde Formation on August 27, 1961.
2. That the proposed non-standard gas proration unit consists of 367.96 acres, which are contiguous quarter-quarter sections and lots.
3. That the proposed non-standard gas proration unit lies wholly within a single governmental section.
4. That the proposed non-standard gas proration unit may reasonably be presumed to be productive of gas.
5. That by copy of this letter of application all operators owning interest in the section in which any part of the non-standard proration unit is situated and which acreage is not included in said non-standard gas proration unit and in acreage offsetting this non-standard proration unit are notified by registered mail of this non-standard proration unit.

Therefore, El Paso Natural Gas Company requests that under the provisions of Rule 5(B) of the Northwest portion of Order R-1670, the Secretary of the Commission grant exception to Rule 5(A) without Notice and Hearing and approve the subject non-standard gas proration unit.




