
Mr. Hansen:




Figure 1 – EME State H EOL location.




Figure 3 – Photographs of plugging and abandonment of the monitor well at EME State H EOL.

Please be advised that Rice Operating Company has plugged and abandoned the monitor well (MW-1) located at the EME State H EOL site (Figure 1) per the specifications given in the NMOCD notice of termination sent via e-mail on June 24th, 2010. This monitor well was plugged on July 26th, 2010 with cement grout containing between 1% to 3% bentonite and a 3 foot cap of cement at the surface. Please refer to the attached driller's report (Figure 2) and photos (Figure 3). With this action we understand that Rice Operating Company has fulfilled their requirements under 19.15.29 NMAC for this project.

Rice Operating Company is the service provider (agent) for the EME Salt Water Disposal (SWD) System and has no ownership of any portion of pipeline, well or facility. The EME SWD System is owned by a consortium of oil producers, System Parties, who provide all operating capital on a percentage ownership/usage basis.
