El Paso Natural Gas Company has made application to the New Mexico Oil Conservation Commission for exception to Rule 4(a) of Order No. 1670-B for a non-standard proration unit Devils Fork-Gallup Pool due to the fact that El Paso Natural Gas Products Company has completed an oil well in the N/2 NW/4 of Section 17, Township 24 North, Range 6 West, N.M.P.M., Rio Arriba County, New Mexico. The completion of this oil well will require the dedication of 80 acres, thereby leaving El Paso Natural Gas Company 240 acres in the Gallup Formation for their Canyon Largo Unit #89 Well located in the SW/4 SW/4 of Section 17, Township 24 North, Range 6 West, N.M.P.M., Rio Arriba County, New Mexico.
