Dear Mr. Bayer:

We have received copies of Form C-104 and C-110 pertaining to a well located in the NW $\frac{1}{4}$  NW $\frac{1}{4}$  Section 31-24N-4W. I presume that this is the location which was originally staked by Raymond Oil and Gas Incorporated and filed with this office on September 19, 1963. I am sending you copies of the original Notice of Intention to Drill and the Well Location and Acreage Dedication Plat and also a copy of a letter we wrote to Raymond Oil and Gas Company on September 20, 1963 pertaining to the approval of a non-standard location for this well. To the best of my knowledge no action has ever been taken by Raymond Oil and Gas Company to secure approval of the non-standard location. Neither have we received copies of Federal Miscellaneous Notices in connection with the drilling and completion of the well.

I am returning the forms which you have mailed to this office. You have not indicated on the Form C-104 whether or not the well is tubed or shown the depth of the tubing. Please add this information in the casing and tubing section. Also please mention in the "Remarks" column the effective date of the transfer from Raymond Oil and Gas Company to Sentinel Petroleum Corporation. Upon receipt of the corrected forms and the approval of the non-standard location we will approve Form C-110 so that the well may not be produced. If we can assist you in these matters in any way, please contact us.
