OXY USA Inc. respectfully requests administrative approval under Rule 104 (F) of this application for the subject non-standard well location on the Lost Tank 10 Federal #1. The #1 well is proposed in the Delaware with a TVD of 8250'. The kickoff point for the well is at approximately 4200' and the top of the Delaware formation is expected at 4035', which is above the kickoff point. The wellbore will not be orthodox at either the top of the Delaware or when it penetrates the Delaware Brushy Canyon reservoir. The non-standard location is necessary for reasons of potash surface restrictions and topography, as required by the BLM.

The #1 encroaches on the 40-acre spacing units of M-Sec 2, P-Sec 3, D-Sec 11 of T23S R31E. All of the interest owners have joined in the drilling of the #1 and waivers have been attached from affected parties.

To support this request, the following information has been submitted for your review:

1. Application for Permit to Drill.
2. NMOCD C-102 Plat for the proposed well with offsetting well and affected spacing units.

Some discrepancies exist in your application for this well. I am inclined to assume that they are typographical errors, but am requesting clarification or correction.

First, your letter identifies the location as 2350 FSL and 250 FEL of Section 3. However, all of the attached documents show the location to be 250 FSL and 250 FEL.

Second, your identification of affected spacing units omits Unit M in Section 2. I assume that omission is inadvertent since you have attached a plat correctly identifying Yates Petroleum Corporation as the operator of that unit and a waiver from Yates. However, again this should be corrected so that the statements in the application will support an order that we can issue.

Third, your identification of affected units refers to T23S, whereas it would appear that all affected units are in T22S. Again, this needs to be corrected.
