
Gentlemen:

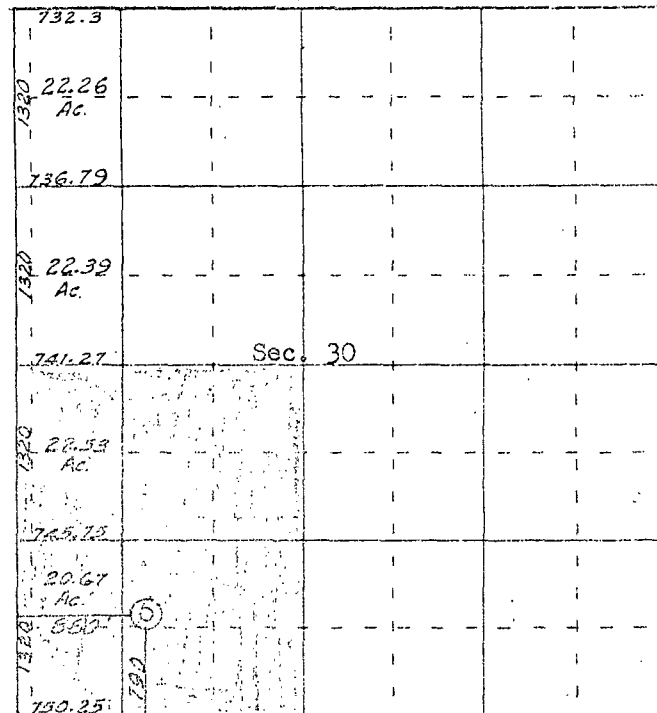
