AGREED COMPLIANCE ORDER;
ACKNOWLEDGEMENT AND WAIVER
OF RIGHT TO NOTICE AND HEARING

Pursuant to the New Mexico Oil and Gas Act, NMSA 1978, Sections 70-2-1 through 70-2-38, as amended ("Act") and OCD Rule 19.15.5.10(E) NMAC, the Director of the Oil Conservation Division ("OCD"), **CANYON E&P COMPANY**, OGRID 269864 ("Operator" or "CANYON") and **U.S. SPECIALTY INSURANCE COMPANY, A SUBSIDIARY OF HCC INSURANCE HOLDINGS, INC.,** (USSIC) enter into this Agreed Compliance Order ("Order" or "ACO").

As set out more fully below, **CANYON** agrees to plug, place on approved temporary abandonment status or restore to production or other beneficial use the wells identified in **Exhibit A** pursuant to the Act and OCD Rule 19.15.25.8 NMAC in accordance with the agreed schedule and procedures; agrees to pay penalties if it fails to meet the schedule; and further specifically agrees that if it fails to comply with this Order, the OCD may plug any well identified on **Exhibit A** that remains out of compliance with OCD Rule 19.15.5.8 NMAC and forfeit the applicable financial assurance, and waives any right to notice and hearing prior to that plugging and forfeiture.

As set out more fully below, **USSIC**, **CANYON's** bonding company, agrees that if **CANYON** fails to comply with the terms of this Order, the OCD may plug the wells identified on **Exhibit A** that remain out of compliance with Part 25.8, may forfeit the applicable financial assurance(s), and like **CANYON**, **USSIC** expressly waives any right to notice and hearing prior to said plugging and forfeiture of the bond for any such wells also specifically identified in **Exhibit B**, attached, which identifies those "**Exhibit A** wells" for which **CANYON** has or will be obtaining a single well surety bond through **USSIC** prior to effecting the transfer of the wells.

In return for **CANYON** and **USSIC** entering into this Agreed Compliance Order with the OCD, and as long as **CANYON** and **USSIC** abide by the terms of the ACO, the OCD agrees to afford **CANYON** certain protections (as more specifically set out below) from the obstacles posed by OCD Rule 19.15.5.9 NMAC to allow **CANYON** to continue operations while simultaneously working to return its numerous inactive wells to compliance.

I. FINDINGS: General

1. The OCD is the state division charged with administration and enforcement of the Act, and rules and orders adopted pursuant to the Act.
2. **CANYON** is a corporation doing business in the state of New Mexico.
3. Upon the approval of permit application No. 117676 (*238 wells to be transferred from Tipton Oil & Gas Acquisitions, Inc., OGRID 211128*), No. 117679 (*65 wells to be transferred from ERS Resources, LLC, OGRID 225298*) and No. 117579 (*8 wells to be transferred from Orbit Petroleum, Inc. OGRID 227083*), **CANYON** will be the operator of record under OGRID 269864 for the **311** wells identified in **Exhibit C**.
4. OCD Rule 19.15.5.9.A NMAC provides, in relevant part:

An operator is in compliance with Subsection A of 19.15.5.9 NMAC if the operator:

- (4) has no more than the following number of wells out of compliance with 19.15.25.8 NMAC that are not subject to an agreed compliance order setting a schedule for bringing the wells into compliance with 19.15.25.8 NMAC and imposing sanctions if the schedule is not met:
 - (a) two wells or 50 percent of the wells the operator operates, whichever is less, if the operator operates 100 wells or less;
 - (b) five wells if the operator operates between 101 and 500 wells;
 - (c) seven wells if the operator operates between 501 and 1000 wells; and
 - (d) 10 wells if the operator operates more than 1000 wells.
5. OCD Rule 19.15.25.8 NMAC states, in relevant part:
 - A. The operator of wells drilled for oil or gas or services wells including seismic, core, exploration or injection wells, whether cased or uncased, shall plug the wells as Subsection B of 19.15.25.8 NMAC requires.
 - B. The operator shall either properly plug and abandon a well or place the well in approved temporary abandonment in accordance with 19.15.25 NMAC within 90 days after:
 -
 -
 - (3) a period of one year in which a well has been continuously inactive.
6. If an operator is out of compliance with 19.15.5.9 NMAC, the OCD **may deny** applications for permits to drill (19.15.14.10 NMAC) and applications to transfer wells to the operator (19.15.9.9 NMAC) and **must deny** applications for permits to inject (19.15.26.8 NMAC) and requests for allowable and authority to transport (19.15.16.19 NMAC). OCD may, after notice and hearing, revoke previously issued injection permits.
7. Upon completion of the planned transfers, **CANYON** will be in violation of 19.15.5.9.A NMAC because it will have too many wells in violation of 19.15.25.8 NMAC. **CANYON** will operate 311 wells. **Exhibit A** (attached) identifies 208 of those wells that are currently out of compliance with 19.15.25.8 NMAC or will be out of compliance with that rule in six months if no action is taken on the wells.

8. OCD Rule 19.15.9.8.B NMAC provides that the Division may deny the transfer of wells to an operator if the designated wells are subject to an order requiring compliance with OCD Rule 19.15.25.8 NMAC and the new operator has not entered into an agreed compliance order setting a schedule for compliance.
9. Of the 65 wells that **CANYON** now seeks to transfer from ERS Resources, LLC (OGRID 225298) under Permit Application No. 117679, **32** are subject to an Order issued under Rule 19.15.25.8 (previously designated as Rule 19.15.4.201) See *OCD Case No.14078, Order. No. R-12979*. That Order required ERS to plug and abandon, obtain approval for temporary abandonment status for, or return to beneficial use 32 wells by November 15, 2008, and further provided that for any of the 32 wells that ERS failed to do so, the Division was authorized to plug and abandon the well and forfeit any applicable bond. ERS did not meet the deadline as to any of the 32 designated wells.
10. NMSA 1978, §70-2-31(A) authorizes the assessment of civil penalties of up to one thousand dollars per day per violation against any person who knowingly and willfully violates any provision of the Oil and Gas Act or any rule or order adopted pursuant to the Act.
11. NMSA 1978, §70-2-33(A) defines “person” in relevant part as: “any individual, estate, trust, receiver, cooperative association, club, corporation, company, firm, partnership, joint venture, syndicate or other entity....”
12. The OCD recognizes that in situations where an operator that is otherwise in compliance with applicable rules is acquiring a large number of noncompliant wells, the result is that the operator is out of compliance with OCD Rules as soon as the operator transfer is approved by the OCD. In such cases, the OCD encourages the operator to negotiate and enter into a compliance order agreement, with terms negotiated based upon the specific facts and circumstances of that particular case, so that the operator is not immediately facing the obstacles posed by Rule 19.15.5.9, is not subject to immediate compliance enforcement action by the Division, and the operator and the OCD agree on a schedule for bringing the newly acquired wells into compliance.

II. FINDINGS: Specifically as to Bonding Company USSIC

1. The **138** wells identified in **Exhibit B** have been or are in the process of being bonded with surety bonds through bonding company USSIC.
2. Canyon has remitted a total amount of \$39,950.15 to **USSIC** in return for the issuance of the **138** surety bonds. The total value of the financial assurance posted on the **138** wells is **\$1,059,678.00**.
3. Bonding company **USSIC** agrees that, as more specifically set out in “Section IV” below, in the event that **CANYON** violates the conditions of this Order or any Amendment to this Order, **USSIC** will waive its right to notice and hearing prior to forfeiture of the bond by the OCD for purposes of the OCD proceeding with the plugging of the noncompliant wells pursuant to its authority under the Oil and Gas Act.

III. CONCLUSIONS

1. The OCD has jurisdiction over the parties and subject matter in this proceeding.
2. The wells identified in **Exhibit A** are either out of compliance with OCD Rule 19.15.25.8 NMAC or will fall out of compliance with OCD Rule 19.15.25.8 NMAC in the next six months if they are not returned to production or other beneficial use, plugged and abandoned, or placed on approved temporary abandonment status.
3. If **CANYON** becomes the operator of record for the wells identified in **Exhibit A**, **CANYON** will be responsible for bringing those wells into compliance with OCD Rule 19.15.25.8 NMAC.
4. **CANYON** is a "person" as defined by NMSA 1978, §70-2-33(A) and may be subject to civil penalties for knowing and willful violations of the Oil and Gas Act or rules or orders adopted pursuant to the Act.
5. The OCD and **CANYON** enter into this Order for the express purpose of enabling **CANYON** to initiate and continue evaluation, repair and operation of the newly acquired wells without being impeded by OCD Rule 19.15.5.9 NMAC, while simultaneously working to return its numerous inactive wells to compliance. In return for **CANYON**'s entry into and continued compliance with this Order, the OCD has agreed to consider **CANYON** to be in compliance with OCD Rule 19.15.5.9 NMAC for all purposes except:
 - *Applications for Permits to Drill* as to new wells (APDs for work on existing wells is permitted), and
 - *Applications for Transfer of Operator* as to acquisition of wells or facilities (transfer of wells *from* **CANYON** to another operator shall be permitted).

IV. ACKNOWLEDGEMENT AND WAIVER OF HEARING IN THE EVENT OF NONCOMPLIANCE

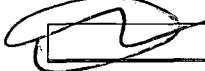
1. OCD Rule 19.15.8.13 NMAC addresses the forfeiture of financial assurance and provides in relevant part:
 - A. Upon the operator's failure to properly plug and abandon and restore and remediate the location of a well or wells a financial assurance covers, the ***division shall give notice to the operator and surety***, if applicable, and hold a hearing as to whether the well or wells should be plugged and abandoned and the location restored and remediated in accordance with a division-approved plugging program. If it is determined at the hearing that the operator has failed to plug and abandon the well and restore and remediate the location as provided for in the financial assurance or division rules, the director shall issue an order directing the well to be plugged or abandoned and the location restored and remediated in a time certain. Such an order may also direct the forfeiture of the financial assurance upon the failure or refusal of the operator, surety or other responsible party to properly plug and abandon the well and restore and remediate the location.

2. By entering into this Agreed Compliance Order with the OCD, both **CANYON** and **USSIC** acknowledge and affirm that they understand that ordinary procedure pursuant to OCD Rules, as cited above, is that upon failure of an operator to properly plug and abandon and restore and remediate a particular site covered by a financial assurance, the OCD provides notice to the operator and the surety, and a hearing is then conducted to determine whether the subject site should be plugged, abandoned, restored and remediated pursuant to a division-approved plugging program.

3. By entering into this Agreed Compliance Order with the OCD, **CANYON** and **USSIC** further acknowledge and affirm that in the event that Canyon fails to plug and abandon or otherwise bring the inactive wells into compliance as agreed and set forth in this Order, both **CANYON** and **USSIC** WAIVE their right to notice under OCD Rule 19.15.8.13 NMAC and release the Division of its obligation to provide such notice of its intention to proceed with plugging of the noncompliant wells. **CANYON** and **USSIC** further WAIVE their right under OCD Rule 19.15.8.13 NMAC to a hearing to determine whether plugging should proceed pursuant to a division-approved plugging program.

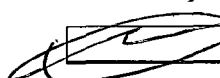

4. **USSIC** acknowledges, affirms and agrees that this Agreement shall be binding on any successors, assigns, and transferees of **USSIC** with regard to the surety bonds posted for the wells identified in **Exhibit B**.

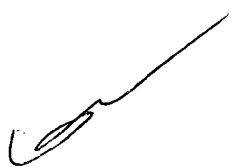
5. By entering into this Agreed Compliance Order with the OCD, both **CANYON** and **USSIC** acknowledge, affirm and agree that this waiver of notice and hearing as to the wells identified in **Exhibit B** survives the term of this Order, any amendment to this Order, or any subsequent Order, and does not expire until such time as the single well bond issued by **USSIC** for each of the **138** wells identified in **Exhibit B** has been either forfeited or refunded pursuant to OCD Rules.

V. ORDER

1. **CANYON** agrees to bring **12** of the wells identified in **Exhibit A** into compliance with OCD Rule 19.15.25.8 NMAC by **FEBRUARY 20, 2011** by
- (a) restoring the well to production or other OCD-approved beneficial use **and filing a C-115 documenting such production or use;**
 - (b) causing the wellbore to be plugged in accordance with OCD Rule 19.15.25.10(B) NMAC **and filing a C-103 describing the completed work;** or



- (c) placing the well on approved temporary abandonment status in accordance with OCD Rule 19.15.25.12 NMAC through 19.15.25.14 NMAC.
2. Oil and gas produced during swabbing does not count as production for purposes of this Order.
 3. CANYON shall file a **compliance report** identifying each well returned to compliance, stating the date it was returned to compliance and describing how the well was returned to compliance (restored to production or other approved beneficial use, plugged wellbore, approved temporary abandonment status). Transfer of a well identified on **Exhibit A** to another operator does not count towards CANYON's obligation to return wells to compliance under the terms of this Order, but does reduce the total number of wells for which CANYON is responsible under the terms of this Order. The written compliance report must be mailed or e-mailed to the OCD's Enforcement and Compliance Manager and to the OCD attorney in charge of this inactive well agreed compliance order so that it is received by the compliance deadline of **FEBRUARY 20, 2011.**
 4. When the OCD receives a timely **compliance report** indicating that CANYON has returned at least 12 wells to compliance and verifies the accuracy of that report, and verifies that CANYON is in compliance with OCD's financial assurance requirements, **the OCD shall issue an amendment to this Order extending its terms for an additional six-month period requiring Canyon to bring 12 additional wells identified in Exhibit A into compliance by the compliance deadline.** OCD shall provide a copy of that amendment to CANYON at CANYON's address of record provided pursuant to OCD Rule 19.15.9.8(C) NMAC. If, in the initial six-month period, Operator returns more than 12 wells to compliance, the wells in excess of 12 will count toward CANYON's requirement of 12 additional wells identified in **Exhibit A** for the second six-month period. ****NOTE: If Canyon is NOT in compliance with OCD's financial assurance requirements, the OCD shall NOT issue an amendment to this Order.**
 5. If an Amendment is issued granting a second six-month period, CANYON shall file a **compliance report** identifying each well returned to compliance in the second six-month period, stating the date each was returned to compliance and describing how the well was returned to compliance (restored to production or other approved beneficial use, plugged wellbore, approved temporary abandonment status.) Transfer of a well identified on **Exhibit A** to another operator does not count towards CANYON's obligation to return wells to compliance under the terms of this Order, but does reduce the total number of wells for which CANYON is responsible under the terms of this Order. The written compliance report must be mailed or e-mailed to the OCD's Enforcement and Compliance Manager and to the OCD attorney in charge of this inactive well agreed compliance order so that it is received by the compliance deadline established by the Amendment.
 6. The total length of this Agreed Compliance Order plus any amendment to this Order as provided in the preceding paragraphs, shall not exceed one year. At the end of one year, CANYON and the OCD may negotiate a new agreed compliance order. To be eligible to negotiate a new agreed compliance order, CANYON must have successfully completed the

first agreed compliance order (including but not limited to bringing at least 24 wells into compliance within the two six-month periods) and be in compliance with all financial assurance requirements. OCD will also consider Canyon's overall compliance efforts with regard to all of its wells. **If Canyon is NOT in compliance with OCD's financial assurance requirements, the OCD will not consider negotiating a new agreed compliance order.**

7. If CANYON fails to bring 12 wells into compliance in the six-month period covered by this Order, or in the six month period covered by an amendment issued to this Order, CANYON agrees to pay a penalty of \$1,000 times the number of wells it failed to bring into compliance under its schedule during the applicable six month period, subject to the terms of this Order. In the event CANYON encounters unanticipated circumstances that prevent it from meeting its goal within the six-month period covered by this Order or any amendment issued to this Order, CANYON may apply for a waiver or reduction of the penalty by making the request in writing to the OCD's Enforcement and Compliance Manager. If the Enforcement and Compliance Manager concurs with CANYON's request, the request for waiver or reduction of penalties may be granted administratively. If the Enforcement and Compliance Manager does not concur with CANYON's request or fails to respond within 10 days, CANYON may file an application for hearing on the request. Any application for hearing on a request for waiver or reduction of penalty must be filed within 30 days of the date the compliance report is due. If relating to this original Order and the original six-month period ending February 20, 2011, once CANYON pays the penalty or applies for a waiver or reduction of the penalty, the OCD may, in its discretion, issue an amendment to this Order extending its terms for an additional six-month period as provided by the terms of this Order. If relating to an amendment to this Order (a second six-month compliance period), the OCD may, in its discretion, choose to negotiate a new ACO.
8. Thirty days after the compliance deadline set by this Order (or any Amendment issued hereto), the protections afforded to CANYON by this Order (as noted above in Section III, Paragraph 5 and below in Section V, Paragraphs 14 and 15) for purposes of OCD Rule 19.15.5.9 NMAC will expire.
9. The waiver of notice and hearing by both CANYON and USSIC as to the wells identified in **Exhibit B** survives the term of this Order, any amendment to this Order, or any subsequent Order, and does not expire until such time as the single well bond issued by USSIC for each of the **138** wells identified in **Exhibit B** has been either forfeited or refunded pursuant to OCD Rules.
10. By signing this Order, CANYON expressly:
 - (a) acknowledges the correctness of the Findings and Conclusions set forth in Sections I, II, III and IV of this Order;
 - (b) acknowledges that an authorized representative of CANYON with authority to contractually bind CANYON has fully reviewed, understands and agrees to the terms of the acknowledgement and waiver set out at Section V, above;

- (c) agrees to return to compliance 12 of the wells identified in **Exhibit "A"** by **FEBRUARY 20, 2011** and agrees to comply with the compliance deadlines set by any amendments to this order;
- (d) agrees to submit a compliance report as required in Ordering Paragraph 3 by the **FEBRUARY 20, 2011** compliance deadline set by this Order and by the compliance deadline set by any amendments to this Order;
- (e) agrees to pay penalties as set out in and limited by Ordering Paragraph 4 if it fails to either return 12 wells to compliance or file a compliance report by the **FEBRUARY 20, 2011** compliance deadline set out in the Order or to abide by the terms of any amendments to this Order;
- (f) waives any right, pursuant to the Oil and Gas Act or otherwise, to an appeal from this Order, or to a hearing either prior to or subsequent to the entry of this Order other than a hearing on a request for waiver or reduction of penalties;
- (g) as more fully set out at Section IV, above, understands that if CANYON should fail to comply with the terms of this Order, or any amendment to this Order or any subsequent Order, the Division is not required either to provide notice to CANYON or conduct a hearing prior to:
 - i. proceeding to plug any wells that have been identified in **Exhibit A** that remain out of compliance with OCD Rule 19.15.25.8 NMAC, and
 - ii. forfeiting the single well financial assurances posted for those wells identified in **Exhibit B** (bonded through USSIC) that are being plugged as noncompliant "**Exhibit A**" wells, above.

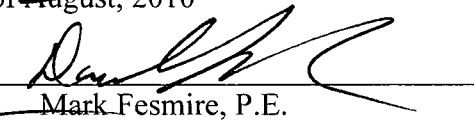
11. By signing this Order, **USSIC** expressly:

- (a) acknowledges the correctness of the Findings and Conclusions set forth in Sections I, II, III and IV of this Order;
- (b) acknowledges that an authorized representative of **USSIC** with authority to contractually bind **USSIC** has fully reviewed, understands and agrees to the terms of the acknowledgement and waiver set out at Section V, above;
- (c) waives any right, pursuant to the Oil and Gas Act or otherwise, to an appeal from this Order, or to a hearing either prior to or subsequent to the entry of this Order, and
- (d) agrees that the Order may be enforced by OCD or Oil Conservation Commission Order, by suit or otherwise, and
- (e) as more fully set out at Section IV, above, understands that if CANYON should fail to comply with the terms of this Order, or any amendment to this Order or any subsequent Order, the Division is not required either to provide notice to USSIC or conduct a hearing prior to:



- i. proceeding to plug any wells that have been identified in **Exhibit A** that remain out of compliance with OCD Rule 19.15.25.8 NMAC, and
 - ii. forfeiting the single well financial assurances posted for those wells identified in **Exhibit B** (bonded through USSIC) that are being plugged as noncompliant "**Exhibit A**" wells, above.
12. This Order applies only to the enforcement of OCD Rule 19.15.25.8 NMAC against those wells identified in **Exhibit A**. Other wells operated by CANYON out of compliance with OCD Rule 19.15.25.8 NMAC may be subject to immediate enforcement action under the Oil and Gas Act and OCD Rules. Wells identified in **Exhibit A** that are out of compliance with the Oil and Gas Act or OCD Rules other than OCD Rule 19.15.25.8 NMAC may be subject to immediate enforcement action under the Oil and Gas Act and OCD Rules.
13. The OCD reserves the right to file an application for hearing to obtain authority to plug any well identified in **Exhibit A** and forfeit the applicable financial assurance if the well poses an immediate environmental threat.
14. This Order shall not generally be considered an "*Inactive Well Agreed Compliance Order*" under 19.15.5.9(F)(1)(c) NMAC and the wells included in **Exhibit A** shall not be removed from the inactive well list kept by the OCD pursuant to 19.15.5.9(F) NMAC.
15. This Order shall, however, be considered an "*Inactive Well Agreed Compliance Order*" under 19.15.5.9(F)(1)(c) NMAC for the limited purpose of removing the wells identified in **Exhibit A** from consideration in determining CANYON's compliance with 19.15.5.9(A)(4) NMAC for all purposes except:
 - *Applications for Permits to Drill* as to new wells (APDs for work on existing wells is permitted), and
 - *Applications for Transfer of Operator* as to acquisition of wells or facilities (transfer of wells *from* CANYON to another operator shall be permitted).

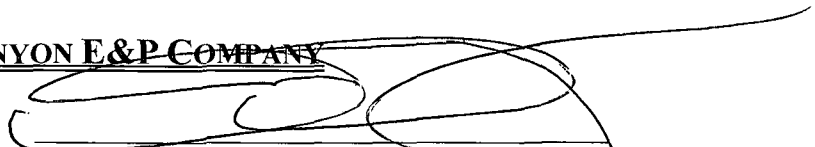

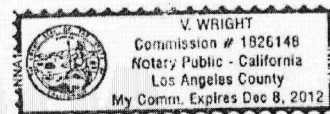
