



RE: **Conoco, Inc.**, Lockhart B 35 Battery, Section 35, T21S, R37E, Lea County, New Mexico

Dear Mr. Catanach,

Concerning the above referenced battery, due to a fire at our Lockhart A 35 battery, we are requesting permission to commingle the production from the Lockhart A 35 battery (Wells #1, 2, & 3) with the Lockhart B 35 (Wells #1, 2, 3, 4 & 5) at the Lockhart B 35 battery. We have established that it will be more economically feasible and environmentally sound to eliminate the Lockhart A 35 battery. The amount of oil going into the "A" battery, before the fire, was approximately 4 bbls oil, 2 bbls water and 197 mcf gas (see table attached). Conoco, Inc. plans to pipe the "A" 35 header to the test and production lines on the "B" 35 battery. There are two tanks and one heater treater that would be eliminated at the Lockhart A 35 battery.

The current pools permitted for the Lockhart A 35 battery are the Blinebry Oil & Gas, Drinkard and Tubb Oil & Gas. The pools permitted for the Lockhart B 35 are the Blinebry Oil & Gas, Drinkard, Tubb Oil & Gas, Wantz Abo, and Paddock.

The crude oil gravity is the same for the Lockhart A 35 and the Lockhart B 35 batteries. The production is on a steady decline. We are proposing that the gas be allocated by testing on a semi-annual basis, due to the consistent nature of the production. We propose that the crude oil and water be allocated on a yearly test basis. We do not anticipate any drilling on the leases in the near future that would effect the current production.






