Nearburg Producing Company is hereby authorized to surface commingle production from the following four (4) wells within the following two (2) pools:

Happy Valley - Morrow (Gas - 78060)

Nearburg Producing Company is a working interest owner and operates these wells - all located in Eddy County. All other interest owners in these wells have been notified and objections to this surface commingling have not been received.

Each of these four (4) wells will have an allocation gas meter installed and regularly calibrated. Gas sales through the CDP will be split back to each well based on each well's percentage of the total of all four (4) allocation meters. Fuel gas will be allocated to each well and gas production calculated and reported from sales plus fuel gas. Condensate and water will be separated from the gas at each well site then measured and trucked.

The transporter's CDP meter will be located in Section 6, Township 22 South, Range 26 East NMPM, Eddy County, New Mexico.

NOTE: This installation shall be installed and operated in accordance with the applicable provisions of Rule 309-B of the Division Rules and Regulations and the Division "Manual for the Installation and Operation of Commingling Facilities." It is the responsibility of the producer to notify the transporter of this commingling authority.

FURTHER: The operator shall notify the supervisor of the Artesia district office prior to implementation of the commingling process.
