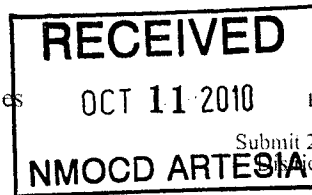



Describe Cause of Problem and Remedial Action Taken.*

The 1 inch roll line behind the oil tanks was corroded and developed a hole. The inoperable roll line has been removed and 1 inch bull plugs have been installed.

Describe Area Affected and Cleanup Action Taken.*

Initially 20bbls of oil was released from the roll line and we were able to recover 16bbls with a vacuum truck. The spill area had the dimensions of 20' x 180' south on the Houma State #1 well location, along with an area to the west in the pasture measuring 2' x 60'. All free fluid has been recovered and the pad location has been scraped and contaminated pad material has been disposed of appropriately. (The closest well location is the Houma State #1 and is on the same pad location as the Tank Battery where the release occurred, 2310' FNL 2310' FWL, Sec. 16-T17S-R30E, Eddy County, NM, B-8095, API# 30-015-31491). Tetra Tech will sample the spill site area to delineate any possible contamination from the release and we will present a remediation work plan to the NMOC D for approval prior to any significant remediation work.

I hereby certify that the information given above is true and complete to the best of my knowledge and understand that pursuant to NMOC D rules and regulations all operators are required to report and/or file certain release notifications and perform corrective actions for releases which may endanger public health or the environment.
