The proposal submitted to OCD for remediation of a produced fluid release that occurred on 8/1/2010 at the above referenced site, is approved. In addition to the BLM's approval and conditions of approval, the following OCD conditions and/or stipulations apply:

- Notify OCD District 2 Office 48 hours prior to commencement of remedial activities. In the event remediation has begun, please advise.
- Notify OCD District 2 Office 48 hours prior to obtaining samples where analyses will be submitted to OCD.
- In the event the excavation target depths are not obtained, notify OCD.
- In the event a liner is to be installed, notify OCD District 2 Office 48 hours prior to installation.
- Submit a Form C-141 marked Final Report, along with a closure report, upon satisfactory completion of project.
- Project is to be completed and closure documents submitted to OCD not later than 2/17/2011.

Be advised that OCD approval does not relieve the operator of liability should their operations have failed to adequately investigate and remediate contamination that may pose a threat to ground water, surface water, human health or the environment. In addition, OCD approval does not relieve the operator of responsibility for compliance with any other Federal, State, local laws and/or regulations.
