The proposal submitted to OCD for remediation of a produced fluids release that occurred on 6/24/2010 at or near the above referenced well site, is approved with the following conditions and/or stipulations:

- Notify the OCD District 2 Office 48 hours prior to commencement of remedial activities.
- Notify the OCD District 2 Office 48 hours prior to obtaining samples where the analyses may be submitted to OCD.
- Lab reports, at this time, may be included in the closure report as requested.
- In the event difficulties are encountered in achieving any of the excavation depths proposed in Table 1, especially in the "AH-1/SB-1" area, contact OCD to discuss.
- Areas backfilled should replicate, as near as possible, the natural grades and contours of the area as existed prior to excavations.
- Contact OCD to discuss any proposed liner installation. If site is approved for liner installation, notify OCD District 2 Office 48 hours prior to installation.
- Submit a Form C-141 marked Final Report, along with a closure report, upon satisfactory completion of project.
- Project is to be completed and closure documentation filed with OCD not later than March 7, 2011.

Be advised that OCD approval does not relieve the operator of liability should their operations have failed to adequately investigate and remediate contamination that may pose a threat to ground water, surface water, human health or the environment. In addition, OCD approval does not relieve the operator of responsibility for compliance with any other Federal, State, local laws and/or regulations.
