An approximate area of 20' X 20'. The flow line was repaired, no oil was recovered. Impacted soils are being excavated and hauled to an NMOCD approved facility. Microblaze was applied to vegetation and over sprayed soils. Depth to Ground Water: >100' (approximately 184'), Wellhead Protection Area: No, Distance to Surface Water Body: >1000', SITE RANKING IS 0. Based on amounts of oil released, soils excavated/removed and remediation with microblaze, Yates Petroleum Corporation requests closure.
