
Describe Cause of Problem and Remedial Action Taken.*

The cause of the problem was due to both a generator failure and an alarm system failure. Both the generator and the alarm system have been repaired and put back into service.

Describe Area Affected and Cleanup Action Taken.*

Initially 175bbls of produced water was released from the water tank and completely contained inside the dike walls of the lined tank battery. We were able to recover all of the free fluid. All contaminated gravel will be removed and we will replace with clean gravel. (The closest well location is the Firecracker State #2, Unit O, Sec.14-T17S-R28E, 990' FSL 1650' FEL, Eddy County, NM, API# 30-015-37506). We will follow up with a C-141 Final Report.

On 8-1-10 at 9:30am, a spill was discovered at the Firecracker St. #2 Battery. A generator malfunction, in conjunction with an alarm system failure, caused the produced water tank to run over. Approximately 175bbbls of produced water was released into the lined dike. All 175bbbls were recovered and disposed. Unsalvageable gravel will be removed and replaced. Problems with the generator and alarm system have been corrected and the battery remains in service. Legal description below.
