The New Mexico Oil Conservation Division (OCD) has received Plains Marketing's (Plains) request to replace two groundwater monitoring wells (MW-7 and MW-8) at the above-referenced site (dated March 14, 2011). The OCD hereby conditionally approves the request to replace the groundwater monitoring wells at the C. S. Cayler Release Site:

Plains must use material to plug the groundwater monitoring wells (MW-7 and MW-8) at the site of a cement grout with 1% to 3% bentonite or other material approved by the OCD. Please submit to the OCD a final installation (MW-7A and MW-8A) and plugging (MW-7 and MW-8) report within 90 days of receipt of this notice.

Please be advised that OCD approval of this request does not relieve the owner/operator of responsibility should operations pose a threat to ground water, surface water, human health or the environment. Plains respectfully requests NMOCD authorization to replace 2 monitor wells (MW-7 and MW-8) at the above referenced site. Monitor wells MW-7 and MW-8 are currently dry due to a regional decline in the depth to groundwater. The replacement monitor wells (MW-7A and MW-8A) will be installed as close as practicable to the monitor wells that they are replacing. Once the replacement monitor wells are installed, they will be utilized as part of the ongoing groundwater remediation effort that is being conducted at the site.
