- Notify OCD 48 hours prior to commencement of remedial activities.
- Notify OCD 48 hours prior to obtaining samples where the analyses will be submitted to OCD.
- Submit a Closure Report and Form C-141 Final Report upon satisfactory completion of project.

In addition, this approval does not relieve the operator of responsibility for compliance with any other federal, state, local laws and/or regulations.
