Describe Cause of Problem and Remedial Action Taken.*

Higher pressure and increased volumes of produced water being rerouted from shut down SWD in Lea County, caused water line rupture, (this release occurred 0.4 miles south of the YPC's Unocal AH U Federal #1 Battery). Vacuum truck called.

Describe Area Affected and Cleanup Action Taken.*

Area approximately 35' X 15', vacuum truck did not pick up any produced water, impacted soils to be excavated and hauled to an approved NMOCD facility. Vertical and horizontal delineation samples will be taken and analysis ran for TPH & BTEX (chlorides results for documentation, YPC will delineate to try and show decreasing levels of chlorides). If initial analytical results for TPH & BTEX are under RRAL's a Final Report, C-141 will be submitted to the OCD requesting closure. Depth to Ground Water: >100' (approximately 448' per New Mexico Office of the State Engineer), Wellhead Protection Area: No, Distance to Surface Water Body: >1000', SITE RANKING IS 0.
