

- 1) The referenced well is located on Fee surface, Fee minerals. The proposed location is non-standard because of proximity to large areas of wetlands. According to NMOCD rules well locations depending on formation drilled must be 660' from the section/quarter section lines. The well location is 575' from the West Section line of Section 17. Therefore the WF FRPC 17 #2 location is approximately 85' too far West. Richardson controls the Pictured Cliffs rights in the NW/4 of Section 17.
 - 2) A C-102 (Exhibit "A") is attached showing the well location and the proration unit for the proposed Pictured Cliffs well. Application for Permit to Drill (APD) (C-101) for this well was submitted to the State of New Mexico via E-Permitting on January 23, 2004. A copy is attached to this application. The West Kutz PC (Gas) will be a new completion in this pool.
 - 3) A map (Exhibit "B") is attached showing the adjoining spacing units and existing Pictured Cliffs wells. Richardson controls the PC rights in the offsetting spacing units, with the exception of those unleased mineral owners below.
 - 4) Certified letters have been sent to unleased mineral owners to notify them of our intentions. Copies of the letters are attached to this application.
 - 5) Existing land use concerns, specifically existing large areas of wetlands, force a non-standard location exception for this action. It would not be feasible to build a legal location to drill this Pictured Cliffs well without damaging large areas of wetlands.
 - 6) Archaeology is not an issue with this well.
 - 7) Directional drilling is not feasible for such a shallow completion.
 - 8) A non-standard location is requested because of topography, i.e. surface conditions (wetlands).
 - 9) I hereby certify that notice was sent to the following offset operators, leaseholders or unleased mineral owners which adjoin the applicant's spacing unit.

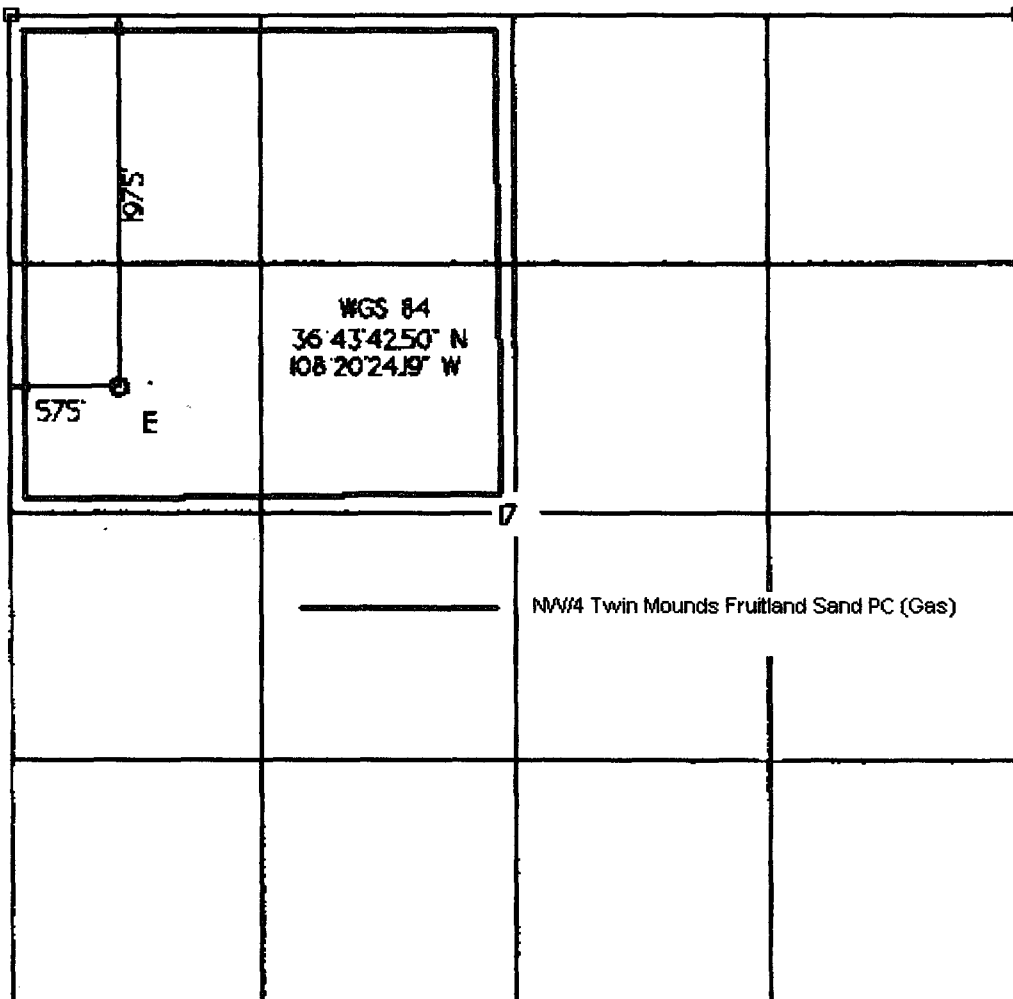

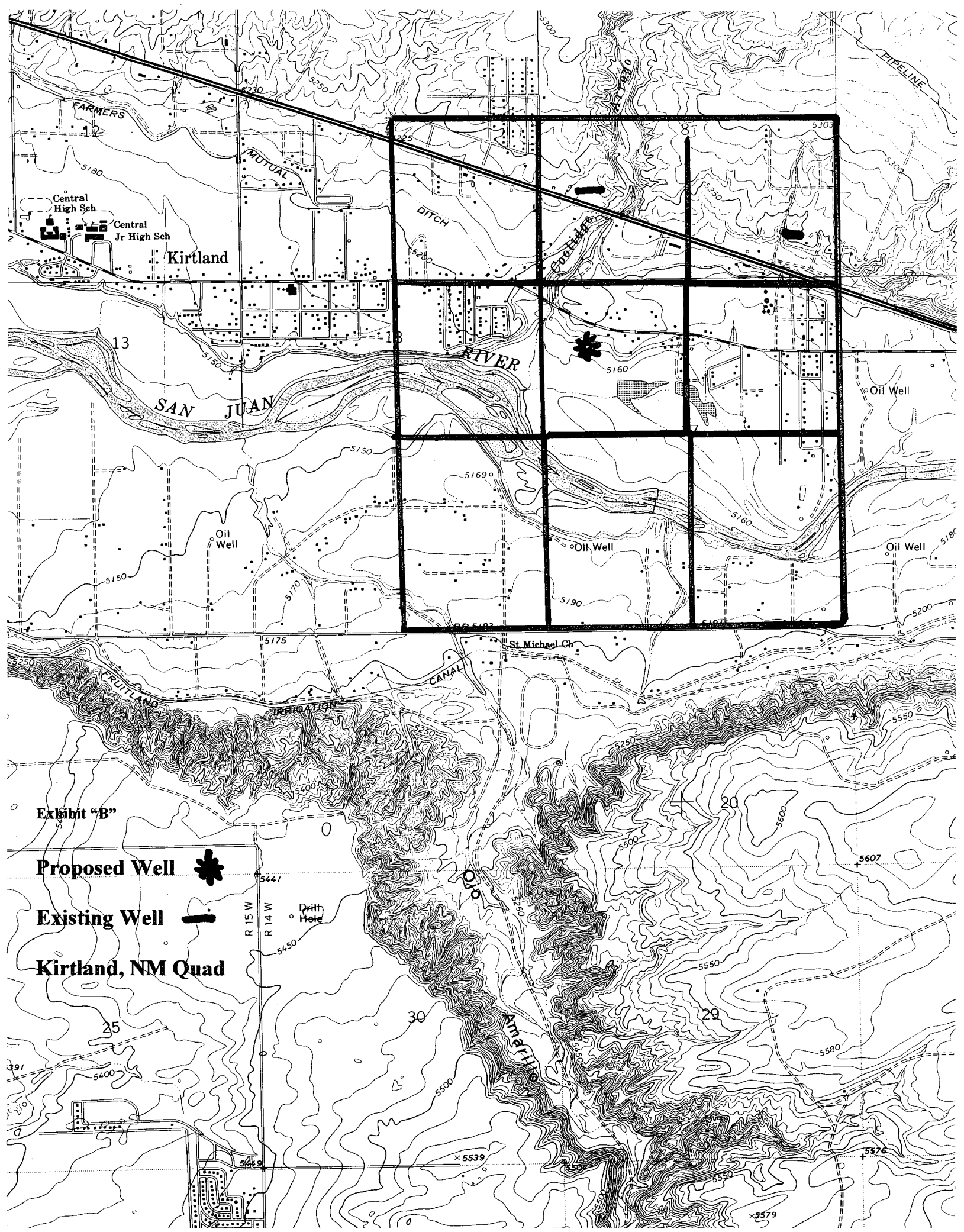


Exhibit "B"
