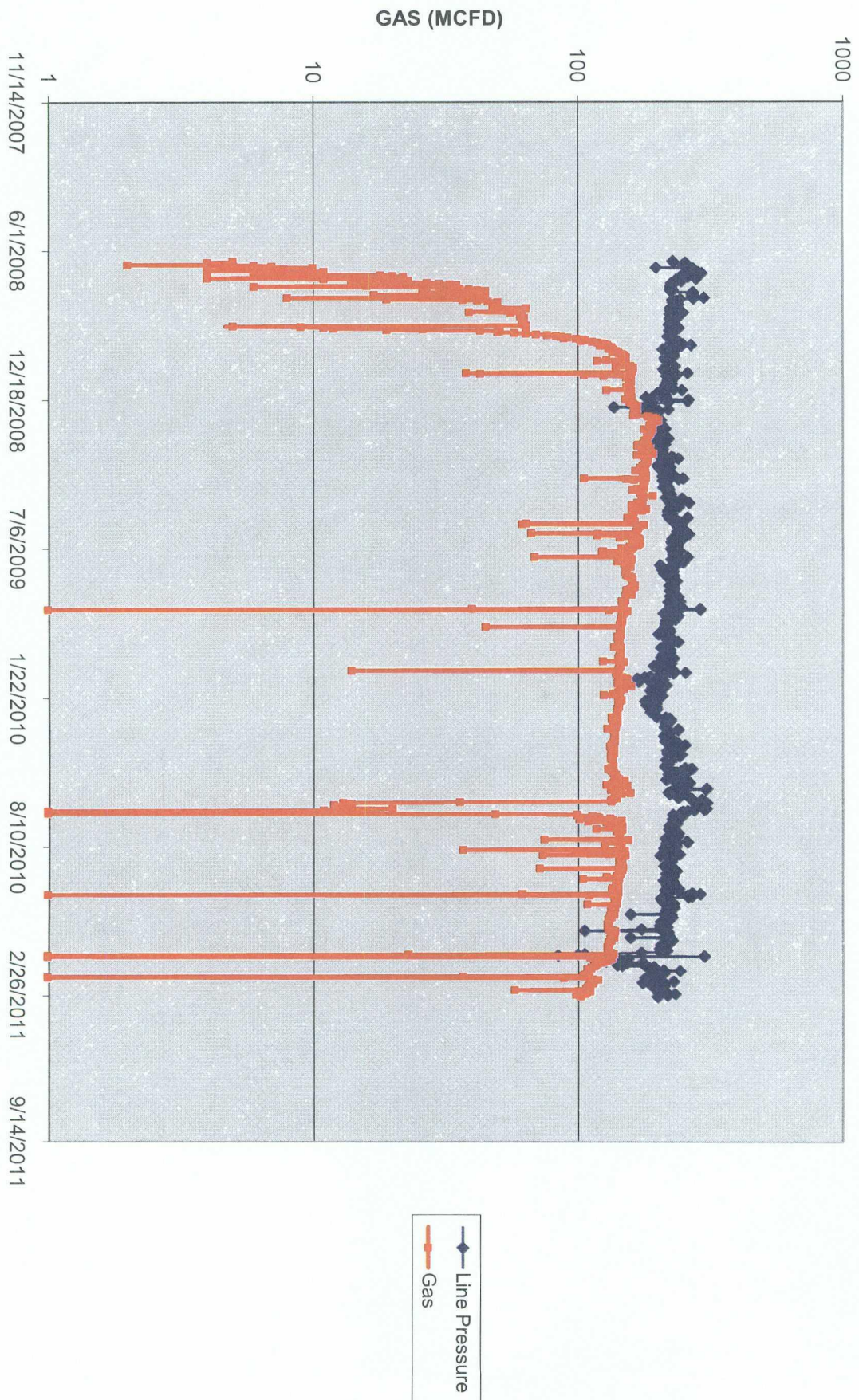

McElvain Oil & Gas Properties, Inc. (MOG) proposes to produce this well as a downhole commingle Basin Fruitland Coal and Fulcher Kutz Pictured Cliffs producer upon the successful recompletion of the Basin Fruitland Coal Pool in accordance with the provisions of NMOC Order R-11363. The Basin Fruitland Coal pool will be perforated from 1,072'-1,366' and the Fulcher Kutz Pictured Cliffs is perforated from 1,380'-1,400'. MOG proposes to allocate production between the zones by the subtraction method using the existing sales meter on location. The production decline from the Fulcher Kutz Pictured Cliffs pool is established. MOG will subtract the Fulcher Kutz Pictured Cliffs production decline volume for the current month from the sales volume to determine the allocation volume for the Basin Fruitland Coal Pool. This proposed commingling will not reduce the total remaining production volume from the pools and will prevent waste and the drilling of unnecessary wells.

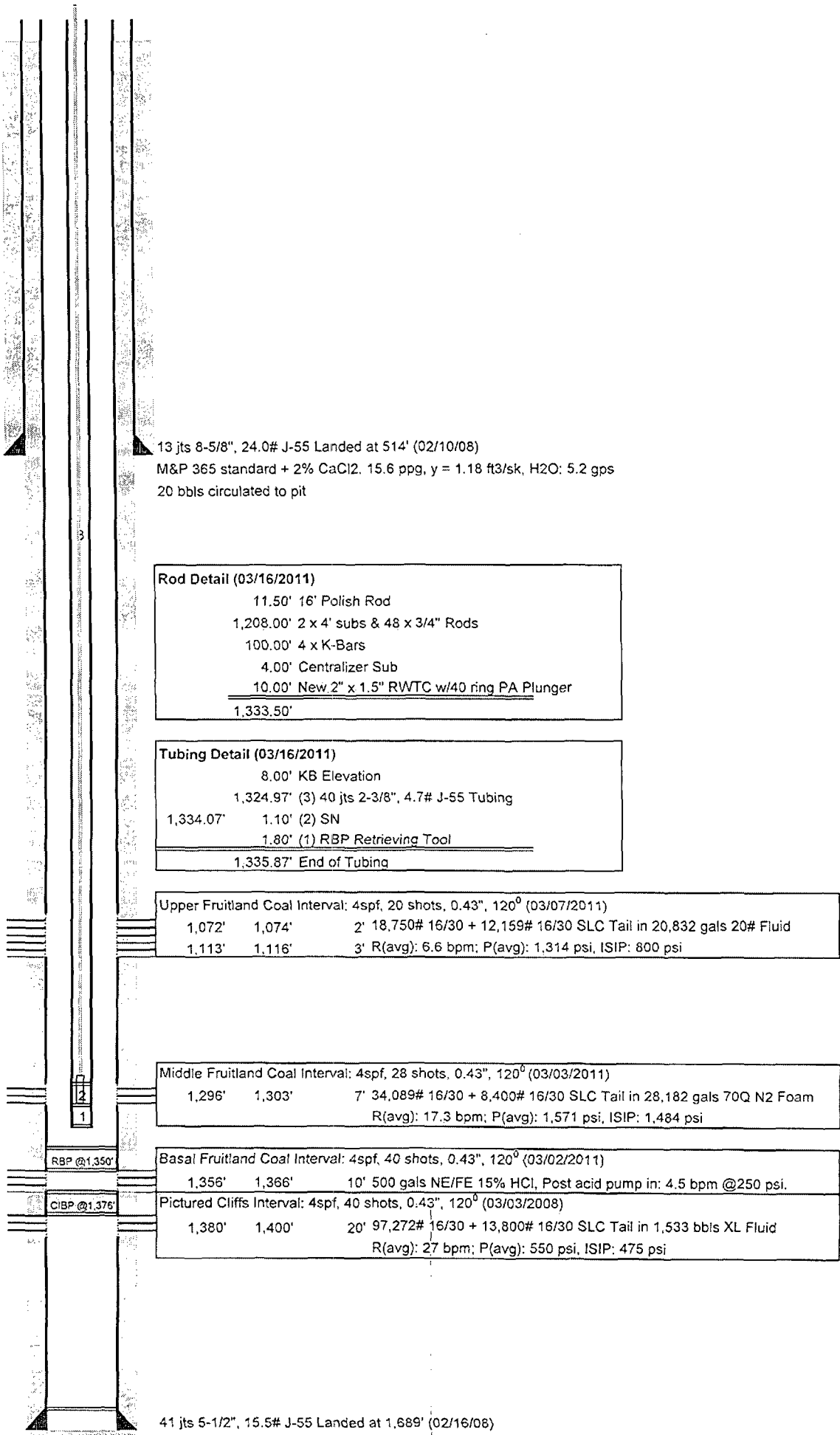
