The flow line froze and ruptured. The well was shut in and a backhoe crew was called to the release area.

Describe Area Affected and Cleanup Action Taken.*
An approximate area of 20' X 40'. The affected area is approximately 0.35 miles northeast of the well pad (just off of the lease road). The flow line was repaired; no oil was recovered. Impacted soils were excavated and taken to an NMOCD approved facility. **Depth to Ground Water: >100'** (approximately 184'), **Wellhead Protection Area: No, Distance to Surface Water Body: >1000', SITE RANKING IS 0. Based on amounts of oil released, all impacted soils removed and depth to ground water/site ranking, Yates Petroleum Corporation requests closure.**
