

Describe Cause of Problem and Remedial Action Taken.* Since the produced water discharge had occurred at an unknown time, all discharged liquid had soaked into the impacted areas both offsite and into the side of the pad adjacent to the southern most water tank. Additionally, during an onsite with the BLM and the NMOCD on 10 February 2011 another suspected unauthorized discharge had occurred on top of the previous one at the tank battery pod area which was visually concurred with by the agency representatives present.		
Describe Area Affected and Cleanup Action Taken.* All contaminated caliche was removed and transported to disposal. Cleanup was conducted in the same manner as delineated in the earlier CAP pursuant to NMOCD regulatory mandates. Sampling defined the extent of the spill area and remediation was conducted accordingly following 10 February 2011 onsite by BLM and NMOCD. See attached laboratory documents for details (CAP/FRR).



Pursuant to the Bureau of Land Management's (BLM) Notice of Written Order (NWO) No. 11-JA-037W for violations noted on the Dublin 23 Federal No. 1 location as cited above, please find attached the documents which have been generated resulting from BLM compliance actions in agreement with the New Mexico Oil Conservation Division's (NMOCD) involvement with some of the issues contained in your Order.

Regarding other violations noted on the Order, please be advised Marshall & Winston have replaced the loadline valve on the southern most tank and corrected the issues with the catchpot. All remediation actions have been completed including seeding with BLM Seed Mix No. 3 based upon the agreement between BLM and the NMOCD during the infield assessment of 10 February 2011, which mandated risk assessment closure predicated on (1) the impenetrable, thick cap rock underlying the discharge area; (2) the extremely high ratio of rock to very thin soil volumes and (3) the depth to groundwater ranging from 70' to 85'.



Valve leaking on the southern most loadline. Repair/Replace. Catchpot is not effective in its current condition, sagging and allowing fluids to run on the ground. Reposition and secure. Spill and/or dumping of produced fluids from the same area, running south off the pad and down the slope. Remove all contaminants to NMOCD standards. Contact Jim Amos @ 575-234-5909 prior to closure and bottom sampling. The location has not been downsized as per APD COAs. Reduce the well pad to what is needed for daily operations. All surfaces disturbed will be reseeded with BLM #3 seed mix.

The Authorized Officer has authority to issue a Written Order in accordance with 43 CFR 3161.2. Written Order correction and reporting time frames begin upon receipt of this Notice or 7 business days after the date it is mailed, whichever is earlier. Each stipulation must be corrected within the prescribed time from receipt of this Notice or reported to the Bureau of Land Management Office at the address shown above. If you do not comply as noted above under "Corrective Action to be Completed By", you shall be issued an Incident of Noncompliance (INC) in accordance with 43 CFR 3163.1(a). Failure to comply with the INC may result in assessments as outlined in 43 CFR 3163.1 and may also incur civil penalties (43 CFR 3163.2). All self-certified corrections must be postmarked no later than the next business day after the prescribed time frame for correction.

Section 109(d)(1) of the Federal Oil and Gas Royalty Management Act of 1982, as implemented by the applicable provisions of the operating regulations at Title 43 CFR 3163.2(f)(1), provides that any person who "knowingly or willfully" prepares, maintains, or submits false, inaccurate, or misleading reports, notices, affidavits, records, or other written information required by this part shall be liable for a civil penalty of up to \$25,000 per violation for each day such violation continues, not to exceed a maximum of 20 days.

Review and Appeal Rights

A person contesting a decision shall request a State Director review of the Written Order. This request must be filed within 20 working days of receipt of the Notice with appropriate State Director (see 43 CFR 3165.3). The State Director review decision may be appealed to the Interior Board of Land Appeals, 801 North Quincy Street, Suite 300, Arlington, VA 22203 (see 43 CFR 3165.4). 
