Pursuant to Division Rule 19.15.15.13, Apache Corporation ("Apache") respectfully requests administrative approval of an unorthodox oil well location for its proposed N B Tween State No. 23. This well will be drilled as a development oil well in the Artesia Glorieta-Yeso Pool (96830).

The proposed N B Tween State No. 23 will be dedicated to an existing standard 40-acre oil spacing and proration unit in the Artesia Glorieta-Yeso Pool comprising the SW/4 NE/4 of Section 25. This unit is currently dedicated to the existing Apache N B Tween State No. 3 (API No. 30-015-35916) located 2160 feet from the North line and 2240 feet from the East line, and the N B Tween State No. 8 (API No. 30-015-36796) located 1850 feet from the North line and 1650 feet from the East line.

The Artesia Glorieta-Yeso Pool is currently governed by Division Rule 19.19.15.9 which requires standard 40-acre oil spacing and proration units with wells to be located no closer than 330 feet to the outer boundary of the spacing unit.

The attached vicinity map shows that the proposed unorthodox oil well location is necessary in order to avoid existing pipelines to the south and east of the proposed location.

The affected offset acreage includes the NW/4 NE/4 and the E/2 NW/4 of Section 25, Township 17 South, Range 28 East. All three of these affected offset tracts are existing 40-acre spacing units in the Artesia Glorieta-Yeso Pool, and all three are operated by Apache. Please note that the working interest ownership between the SW/4




