Good Morning Gentlemen,

Please see the attachment for info regarding this request for closure at OXY's Cimarron 23 Fed #1. As a reminder, all released fluids remained inside the walls of the battery and nothing outside the battery walls was affected. Depth to groundwater is 100', based upon the Eddy County Depth to Groundwater Map.

The affected areas inside the battery were the east, south and west sides of the battery. The affected areas have been excavated to a depth of approximately 4' BGS. Soil samples were obtained from 5 sample points with both field test and lab analysis conducted on the samples. See the attached chart (chloride results) and sketch for corresponding sample points. The presence of TPH and BTEX was eliminated at approximately 3' BGS. Sample points 2 & 3 were the points of concern with the field test indicating higher levels of chlorides than the adjacent points. Delineation of these two points was conducted until field test indicated levels at or below closure levels at which point these samples were taken to the lab for analysis.

Based upon the information provided, I am requesting permission for closure and backfill of the excavated area. Upon approval, a final C 141 will be submitted with supporting documentation.
