COG Operating, LLC [OGRID 229137] (COG) has requested to drill the abovereferenced well at an unorthodox oil well location, described above in the caption of this letter. The NW/4 SE/4 of Section 28 will be dedicated to this well in order to form a standard 40-acre oil spacing and proration unit in the Grayburg Jackson Seven Rivers-Queen-Grayburg-San Andres-Glorieta-Yeso Pool (97558). This pool is governed by statewide Rule 15.9 [19.15.15.9 NMAC], which provides for 40-acre units, with wells located at least 330 feet from a unit outer boundary. This location is less than 330 feet from the eastern unit boundary.
