Exception to Rule 309 (a)

Gentlemen:

Reference is made to your application for administrative approval for exception to Rule 309 (a) in the Maljamar Pool.

It is understood that this exception to Rule 309 (a) is to be ascribed to your State "A" lease, known as State Lease No. B-4062-2, which is the 40 acres described as the SE/4 SE/4 of Section 16, Township 17 South, Range 32 East, which has Well No. 1 on said tract and your State "B" lease, known as State Lease No. B-2366-10, which is 280 acre lease described as the NE/4, NE/4 SE/4 and W/2 SE/4 of Section 16, Township 17 South, Range 32 East, which has one well or Well No. 1 in the SW/4 SE/4 of said lease, all in Lea County, New Mexico.

By authority granted me under provisions of Rule 309, Section (b)-6 as set forth in Order R-645, you are hereby authorized to operate a central tank battery on the above-described acreage as an exception to Rule 309 (a).
